Yucca is a rich source of steroidal saponins, whose extract works as a natural surfactant and wetting agent. Surfactants increase water penetration & promote a more uniform movement of water within soils, reducing dry spots and water channels, while increasing soil permeability and structure. **Ez-Gro Yucca** can be added to fertilizers, micronutrients, supplements, and organics to increase spreadability and add additional protection against drought, heat, salt, and UV stress.

Application Rate:

Shake well before use. Add water first, then product to mixing tanks.

Wetting agent for agricultural field crops:

Add 20 ml of Ez-Gro Yucca for every 100 L of final volume in spray tank.

Horticulture:

Begin foliar application after transplant or emergence unless otherwise specified.

CROP	APPLICATION RATE	INSTRUCTIONS
Problem Soils	250ml/100m2	Apply as needed to improve soil
Fertigation	2L/ha	Apply weekly
Row and Field crops - new seedlings or transplant	2L/ha	Add to starter or side dress. Reapply every 2 weeks.
Fruit & Vegetables	100ml/100L water	Spray transplant or at 3-5 leaf stage. Reapply every 2 weeks or combine with nutrient solutions, pesticides/herbicides.
Potted vegetables, herbs and flowers	1.5g/1L water	Apply every 2 weeks in hot weather.
Flower beds & Ground cover	100ml/100m2	Apply every 2 weeks in hot weather or as needed
Tees & Greens	100 ml/100m2	Apply monthly beginning at green up.
Sods & Lawns	100ml/100m2	Apply monthly or as needed.
Soil & Compost	2ml/1m3	Apply to soil/compost with enough water for coverage and mix thoroughly. Reapply as necessary to improve water and nutrient penetration.
Hydroponics & Cannabis	Option 1 - 0.5ml/1L water	Apply to reservoir weekly through grow and bloom
	Option 2 - 0.5ml/1L water	Apply to foliage weekly through grow and bloom
	Option 3 - 1ml/1L water	Drench soil weekly through grow and bloom
